In 2010, the legal regime regulating the opening, modification and operation of private health service units was changed.



Who?

Since then, many other legal instruments have been published, obliging private healthcare operators to take into account many factors related to internal organization, human resources, functioning, facilities and occupation, and even the existence of certain technical apparatus.

One of the main needs arising from the new control methods is the Direct Medicines Acquisition Authorization (ADMed). This is mandatory to all doctor's offices and other health establishments that must have available on their premises a set of medicines to provide or apply in the course of therapy or analysis.

We have a lot of experience in submitting requests for ADMed to Infarmed (Portuguese Medicines Regulatory Agency) and in a short time we deal with all the respective bureaucracy.
